Further to your request and to the ABS Quality Assurance Quality System Audit and to the ABS Quality Assurance Rolled Steel Product Quality Audit, documents AN3194074, carried out at SA INDUSTRIEL BELGIUM, Charleroi, Belgium dated 14 September 2016, we advise that all requirements for plant and product approval under the Bureau's Quality Assurance Programme for all ABS grades are fully met.

To maintain approval of the quality assurance system steel mill will undergo annual audits and periodic audits, as described below:

Annual Audit - An audit is to be carried out on an annual basis (within 1 month of the yearly anniversary date)

Periodic Audits – Two (2) periodic audits are to be carried out in each year, except that the annual audit may replace one of the periodic audits.

The approval is valid for five years and it will expire on 07 September 2021. Please note it is the responsibility of the facility to inform ABS of any changes to the manufacturing parameters and request renewal of approval prior to the five year expiry date. Our invoice to cover the cost of the technical review is subject to a separate correspondence.
